¹ The Henry Jones Family, described herein, should not be confused with another old Jones Family likewise early situated in Anne Arundel and Prince George's Counties, Maryland (of which this annotator and many others are descended), namely, that of Thomas Jones, of *Robin Hoods Forest* in the Great Fork of the Patuxent, circa 1723; see the charts at pages 66 and 67 of Patricia Reynolds Hundley's *The Woodward Family of Anne Arundel and Prince George's Counties, Maryland 1703 – 1850 A Revised Genealogy* (The Grassland Foundation: 2006), even though some descendants of both families lived fairly close to one another at times; if there was any relationship between these two apparently separate families, it must have preceded the arrival of their respective earliest American ancestors on "this side of the Atlantic". Both families may have been of Welsh extraction. (There were "points of contact" (i. e., intermarriages) between descendants of both of these two families, however, and we have attempted to point them out, as we have found them, by way of footnotes, primarily.)

FOREWORD

by G. Marie Biggs (circa 1972)

At the time I [G. Marie Biggs] started the JONES family I knew the names of my great grandparents and my great great grandparents and thought I would make a Single Lineage Chart from the present and go as far back as I could. When I started to record the names I realized that I knew all but one of the names of my great aunts and uncles. It was then that I decided to include them and as many of their descendants as I could.

A number of some of the seven branches were most cooperative and contributed what information on their branch that they could. Some parts I found from research.

Much of the first five generations came from *Colonial Families of the United States of America*, Vol. 2, pp. 396 - 400, by Mackenzie. Most dates have been verified, some changed and some added. The land grants named in this account are definitely in question as I have found proof of the inaccuracy of all three claims.

Although I have tried to give complete, accurate information you will, no doubt, find errors and many missing parts. My intention is to continue adding to this story where possible and correcting inaccuracies where needed. If I do not, perhaps someday someone will use this as a lead and do sufficient research to write a complete account of the JONES family of Anne Arundel County, Maryland.

NOTE: Please read at least your part of this story, make a note of all errors with corrections and the pages where the errors occur. Also, please do the same for any omissions you note, sending what you would like added. I hope to follow up on this record and send each one a corrected form as complete as possible. Will you help?

THE JONES FAMILY

OF

ANNE ARUNDEL COUNTY

HENRY JONES 1

The Jones family settled in Anne Arundel County, Maryland, about the middle of the 17th century and have been continuously landowners practically in the same neighborhood from that time until the present. The first of this line of whom we have any authentic records was Henry Jones, the settler, who had surveyed for himself Pierpont Branch 4th February 1669 which land was held by his descendants for several generations. When and whom Henry Jones married we do not know, but he had at least one son.

JOSEPH JONES 2

Joseph Jones of Anne Arundel County, Maryland, owned, prior to 1706, a tract of land called *Dodon*. He was buried at All Hallows Church, 16th January 1708. He married firstly, Elizabeth Clarke, prior to 1673, (she died sometime after 2nd November, 1700,

date of her daughter, Savannah's birth). She was the daughter of John Clarke. Secondly, he married Elizabeth Elder, in *All Hallows* on 16th February 1703. The second wife died in childbirth and was buried at *All Hallows*, 26th May 1704, leaving one daughter, Elizabeth, who was baptized in *All Hallows* Church, 11th June 1704.

Richard Jones, son of Joseph, Jr., and Mary (Pybern) Jones, of White Plains and Pierpont Branch, Anne Arundel County, Maryland, married in *All Hallows Church*, 15th July, 1718, Elizabeth Clarke, born in Prince George's County, 10th May 1700 and baptized in *All Hallows*, 24th February 1701, daughter of Richard and Elizabeth (Duvall) Clarke, and granddaughter of Neale Clark.

HENRY JONES ₅

Henry Jones, son of Richard and Elizabeth (Clarke) Jones, b. 14th August 1733, Will (A. A. Co. Will Liber TG #1, folio 343, 344) dated 11th March, 1786, and was probated October 19, 1786 (Rebecca, his wife, declined to serve as executor on 21st October 1786, and requested Thomas Harwood, Jr, also named as executor to serve alone). He is buried at All Hallows Church, Anne Arundel County. He was a member of the very exclusive South River Club of Anne Arundel County in 1775. He married by license, 4th October 1777, Rebecca Knighton and in *All Hallows Church* on 16th October, 1777.

Isaac Thomas Jones was educated at the West River Classical Institute, Anne Arundel County, Maryland, and at Lafayette College, Pa., from which he was graduated. After his graduation, he read law in the office and under the instruction of the eminent lawyer, Thomas S. Alexander of Baltimore. After being admitted to the bar, he practiced for awhile in Baltimore City, and then settled at Ellicott City, Howard County, Maryland. In 1867, he was elected to the House of Delegates from that county. In 1882, was elected Judge of the Fifth Judicial Circuit, and upon the expiration of his term, fifteen years later, 1897, reelected without opposition, both of the leading political parties favoring him. In 1899 he was elected Judge of the Court of Appeals of Maryland and served as such until his death, making in all a service of about twenty-five years on the bench. He was for many years a vestryman of Grace P.E. Church, Elkridge, and repeatedly a delegate to the Diocesan Conventions, also a delegate to the General Episcopal Triennial Convention at San Francisco in 1901, and again in 1904 at Boston.

Henry Jones, son of Henry and Rebecca (Knighton) Jones, b. 23rd April 1781, baptized in All Hallows Church, Anne Arundel County, Md., m. (firstly) 6th January 1807, Mary Elliott; m. (secondly) 15th February 1814 in A. A. Co., to Marsha Tillard, b. 4th February 1788 in St. James' Parish and was the daughter of William and Martha (Hall) Tillard.

SAMUEL JONES 6

Samuel Jones, the seventh and last child of Henry and Rebecca (Knighton) Jones, was born in Anne Arundel County, Maryland, on 26th March 1784 and baptized in *All Hallows Church*, Davidsonville. He married 3rd October 1814, Sarah (Brashears) Ball, widow of John Ball, having married him in Prince George's County, 23 Jan. 1812, b.1790(?). By the first marriage she had a daughter, Elizabeth Ann Ball.

John Ball was the grandson of Joseph Williams of Anne Arundel County and Elizabeth Ann Ball, inherited a share of the money from the sale of Joseph Williams' estate.

Samuel Jones was named guardian of the stepdaughter and guardianship papers were filed in Anne Arundel County, November 25, 1821 and updated in November each year thereafter. The final settlement was made 30th April 1829. (See Guardianship Accounts Book THH #2, p.p. 61, 91, 254; and Book TTS #3, p.p. 76, 219, 342, 448; and Book TTS#1, p.p. 51 and 105.)

Samuel Jones, d. 2nd October 1832, the same day his seventh and last child, Samuel, Jr., was born. He is reportedly buried in the family lot near Mount Tabor. It is now abandoned.

Sometime after his baptism the family became Methodist and were faithful attendants of the Methodist Church. Many of his descendants still attend Davidsonville Methodist Church and many are buried in the church cemetery.

When Rebecca (Knighton) Jones died is not known but she was living in 1850 when the U.S. Census was taken and is said to have been buried in the family cemetery [lot] with her husband.

WILLIAM JONES 7

William Jones, first child of Samuel and Sarah Jones, b. October 4, 1816; d. Jan. 20, 1899, married by license 17th September, 1842, Eveline Waring, b. Feb. 29, 1814; d. Jan.18, 1880.

William Jones was a carpenter and an undertaker when occasion needed him. According to Methodist Episcopal Church Conference Minutes found in location 27 in the Maryland Historical Society, he was appointed a licensed official leader at Cross Roads (now Baldwin Memorial Church), Anne Arundel County. No issue evolved from this marriage but relations who remembered them said they reared twenty-three boys, among whom were Duvalls, Whittingtons, Warings, Havilands, McCauley and others. William and Eveline Jones are both buried in Baldwin Memorial Church Cemetery. On his grave stone very appropriately is the following:

"This modest stone marks his resting place, and will crumble into dust; but he has enduring monument in his ceaseless, unselfish deeds of kindness to others; no children of his own, yet father to many."

Eveline Jones' marker was erected by an organization of the church and beside her dates it bears the following inscription:

"Faithful, true and kind; a zealous servant of the Lord."³

3 William Jones is credited with having been the carpenter/builder at Severn Cross Roads, Millersville, Anne Arundel County, Maryland, of the Cross Roads Methodist Episcopal Church (now and today Charles W. Baldwin Hall, which today, as enlarged and modified beginning *circa* 1935 and thereafter, is situate on the old *Warfields Plains* "home" lot (2.01 acres, more or less, at the northwest corner of the Severn Cross Roads intersection), which is today owned and administered as a community hall by Severn Cross Roads Foundation, Inc. For some years prior to the Civil War, Mr. and Mrs. Jones owned and presumably occupied the farm on Millersville County Road and Waterbury County Road which they later sold and conveyed , in parts, to (a) the Anne Arundel Academy, which became the site of that Academy's principal buildings; and (b) the balance to William Henry Baldwin, Sr. and Jr., which ultimately became parts of (1) the "Gantt/Duker" farm and homestead known as *Hardythe* at the intersection of Millersville and Waterbury Roads; and (2) additional real estate which was later conveyed by the Baldwins unto the Anne Arundel Academy and which fronts on the West side of Millerville and the North side of Waterbury Roads.

Today, in the Cemetery at Severn Cross Roads, Millersville, Anne Arundel County, Maryland, of The Baldwin Memorial United Methodist Church, in a line which runs from West to East roughly parallel to and with the "back end" of the Stone Church of 1896, are the recently and partially restored nineteenth century-type single apiece grave stones for each of William Jones and his wife, Eveline (Waring) Jones, Carrie Frances (Waring) Meade and her husband, Dr. Walter Carr Meade, Jr., and their young daughter, Carrie Waring Meade (who died when she was not quite two years of age) (these stones are not necessarily in the same order as above recited, but they are all together as one group or line), and most of these particular stones have fairly recently been "reset" in the ground. Mrs. Jones and Mrs. Meade were two Waring sisters. Another of their sisters, Rachel Maria Waring, who was a wife of Richard Isaac Duvall, is interred in another location within the same cemetery. According to the 1880 Federal Census tracts (Source: FHL Film 1254494 National Archives Film T9-0494, page 53B, living together as one household in Anne Arundel County, Maryland's 2nd District were: William Jones (carpenter and undertaker), aged 64; Caroline Meade, his sister (in-law), housekeeper, aged 50; Barton E. Duval, a nephew, student, aged 17; Julius Hillary, his "cousin", carpenter, aged 36; Julius Pumphry, described as his "son", aged 11; Samuel Scrivener, relationship: "other", farm laborer, aged 21 (he was a brother of Mrs. William H. Anderson, Sr.); and Virginia Harris, relationship: "other", a black domestic servant, aged 20. It would be interesting to know exactly where in the Second District this household of William Jones (then recently a widower) was located. By this time the William Joneses had earlier sold and conveyed all of their earlier farm and real estate on Millersville Road, where the Anne Arundel Academy was then located. Query: Might William Jones and his then (1880) "family" been allowed to continue to reside in one of the homes then standing on the real estate of the Anne Arundel Academy in exchange for his (Jones's) services as carpenter and/or supervisor of maintenance and grounds at the (always financially "strapped") Anne Arundel Academy? Another possibility (which perhaps makes more sense) is that, since Dr. Walter Carr Meade, Jr., had died on January 25, 1880, and since his wife and widow, Caroline Frances (Waring) Meade, survived him and was living, following his death, as part of the household of her brother-in-law, William Jones (the carpenter and undertaker), perhaps for awhile Mrs. Meade and her brother-in-law, and the others named in the Census tract of 1880, lived together in the Meade household, which was located on the north side of Indian Landing Road, near Severn Cross Roads (the old white frame home, still standing in part, that was later the "retirement" home of Dr. Charles W. Baldwin, D.D., and which is today owned by former Anne Arundel County Executive Janet Owens and her husband. This was the (site of the) ancient home which the late William Henry Baldwin, Sr., had had rehabilitated for Dr. Meade and his family when Dr. Meade came to the Cross Roads to be the resident physician there. This was the old home which was known to the Severn Cross Roads Baldwins as *Dundridge Oaks* (so called after the name of the Baldwins' assumed place of origin in Dundridge, Buckinghamshire, England, of their ancestors), which home had also earlier been a home for some of the early Sewells at that location. Today this *Dundridge Oaks* home and parcel is the real estate which immediately borders that of The Baldwin Memorial United Methodist Church on the North side of Indian Landing Road at Severn Cross Roads.

Company." This business became one of the largest concerns in South Carolina. He also dealt extensively in the cotton business which still operates under the name of "Morgan Jones Cotton Industry."

After his retirement in 1924 he was president of the National Exchange Bank, conducted an extensive loan business of his own and was director of the Aragon Baldwin Cotton Mills. He was an elder in the Purity Presbyterian Church to which he gave a large gift in the way of remodeling the building and now it is one of the most handsome churches in this section. He also gave considerable money toward the Sunday School building of the church; he established a \$5,000 scholarship at Presbyterian College and gave generously to orphanages and other causes. In memory of his wife he gave the lot on which the "Dora Jones School" building was erected. He gave liberally to the Chester Library. Both Morgan Jones and his wife Dora are buried in *Evergreen Cemetery*, Chester, South Carolina.

Ms. Shockley also descends from Joseph F. (middle name: Fry) Jones, Sr. (see text above) through one of his sons, William Tudor Jones (see text above). The oldest child, Elizabeth Eleanor Jones (1890 – 1972) Scharf (Mrs. Thomas Marion Scharf, Sr.) of William Tudor Jones, Sr., is a grandmother of Ms. Shockley. Thus, Ms. Shockley is a direct descendant of Eleanor (Williams) and Richard Warfield Turner, the parents of Thomas Williams Turner (the owner of *Warfield Plains* at the Severn Cross Roads, Millersville, Anne Arundel County, Maryland, who was the donor/grantor of both (a) the original three-quarters of an acre site of the three churches which were and are at the Severn Cross Roads; and (b) the adjoining *Bunker Hill* farm of the William Henry Baldwin, Sr., descendants at the same approximate location. See other publications of The Grassland Foundation, Inc., for additional and further details. See also Vol. 1 (of 7) *Colonial Families of the United States*, pages 553-557, by Mackenzie (this entire series now available on one disc through Heritage Books, Inc., its Year 2001 CD ISBN 0-7884 – 1874 – 2).

One of the daughters, Virginia Catherine Turner, of Thomas Williams Turner and Charlotte (Marriott) Turner, his second wife, married, as his second wife, Dr. Christopher Raborg, M.D., of Baltimore City, in 1819, and of Dr. Raborg's issue by his first marriage (to Ann McManus), there was born a daughter, Mary Harriott Raborg, who became the first wife (and mother of his children) of Rignal Thomas Woodward, Sr., son of Rignal Duckett Woodward, of *Abington* Farm at Millersville, Maryland (see footnote no. 107, appearing on pages 95-96, in *Extract of Diary or Farm Journal of William Anderson of “Grassland” 1853 to 1875 and Certain Related Documents* (September 1, 1993: The Grassland Foundation, Inc.); and also see the biographical sketch pertaining to the late Mrs. Virginia Catherine (Turner) Raborg appearing on pages 411 to 413, inclusive, in the biographical Volume IV of the *Tercentenary History of Maryland* (1925: Henry Fletcher Powell, by The S.J. Clarke Publishing Company).

The oldest members of this branch of the Millersville Woodwards are interred at what is today the Cemetery of Our Lady of the Fields Roman Catholic Church on Cecil Avenue at Millersville which cemetery began about 1900, more or less, as the private family burial grounds for this branch of the Woodward family, on a portion of the *Abington* Farm which had been conveyed unto Rignal Thomas Woodward, Sr., by his father, Rignal Duckett Woodward, prior to the father's death, and which remained in the family of that branch of the Woodwards for several generations and until approximately 1936. One McManus lady is also interred there.

Co., attended the Davidsonville Methodist Church and are buried in the church cemetery. as are many of their children. There are memorial windows in the church for Levin and Georgianna Hardy.

7 This annotator remembers two of Ms. Shockley's great aunts, both public schoolteachers: Misses Nellie May Jones (who became an elementary school principal, who earlier (*circa* 1925) had taught at the old Saint Margarets Elementary School; and (b) her sister, Monterey (Jones) Enright, who had boarded for a few years at the *Anderson's Corner* real estate of this annotator's Anderson grandparents *circa* 1925 either .with the grandparents or with his own parents while she was an elementary school teacher at the then new and close by first Millersville Consolidated Elementary School. Years later, after Mrs. Enright, as a widow, had returned to Anne Arundel County, this annotator and his wife met Mrs. Enright at a neighbor's Christmas party one year, on an occasion when she was being escorted at the party by Jessup resident and widower, Kenneth Hammond Fields, Sr., who, years earlier, had met Mrs. Enright while she had been teaching at Millersville at a time when Mr. Fields, as a young man, was renting (from my grandparents) and operating in the old original and first gasoline filling station building at *Anderson's Corner* an automobile repair business (which building had earlier been moved and placed "behind" the later and much larger combination store, home, garage, and Esso gasoline filling station which became the "second" *Anderson's Corner* building which survived until the first decade of this 21st century). Kenneth Hammond Fields, Sr., (now deceased), whose name appears later in this narrative in conjunction with Jones family descendants who had the last name of Biggs, residing at Jessup, was a skilled artisan in addition to being a "top flight" motor vehicle repairman who was also a direct lineal descendant of one of Anne Arundel County's earliest families, the Hammonds of Gambrills and Odenton, Maryland. After my parents had constructed and occupied their then new (1927) home that stood next to and "behind" the old automotive repair garage then being operated by Mr. Fields, Mr. Fields and his late attorney father, Mr. Frank Fields, of Jessup, were frequent visitors at the home of this annotator's parents (where Kenneth Fields and this annotator's father frequently played checkers with each other during the evenings until Mr. Fields married and relocated to Jessup).

Samuel and Elizabeth (Swift) Jones lived near Davidsonville, Anne Arundel County, Maryland, until about 1870 when many of the laborers left the country and they had to give up farming. He was appointed Tobacco Warehouse Inspector and moved to Baltimore where he stayed until about 1880 when he moved to Annapolis Junction, Anne Arundel County. At this time he was employed at the U.S. Printing Office, Washington, D. C.

After a few years the family moved to Jessup and lived on the property now [1972] owned by Kenneth Fields, Sr. In 1899 or 1900 the house burned⁸, but they continued to live in Jessup. They are buried in Lorraine Cemetery, Baltimore, in the lot of their son, S. Holliday Jones (Lots #583-4). Their graves are duly marked.

Samuel Jones was born the day his father died. In his day folks seemed to believe that a male child born without having seen his father had power to prevent a child from having whooping cough by blowing his breath down the child's throat. He frequently told the story that neighbors for miles around would send for him whenever there was a new baby to have him blow down its throat to safeguard it from whooping cough. No one can tell us whether or not this preventative worked.

Elizabeth Hatton (Swift) Jones, was born in Baltimore and lived there until her marriage when she moved to Davidsonville, A. A. Co., Md. She was one of a large, well-to-do family. Little more is known of her at this time.

S. Holliday Jones was born in Anne Arundel County, Maryland, and grew up in Baltimore City. He went to Nebraska as a young man, and was deputy county treasurer of Sioux County from 1_____, when the county was first organized, until October 3, 1891. At this time he was appointed by the United States Government as chief clerk in the Indian Agent's Office at Darlington (Indian Territory), Oklahoma, a post he kept until the early part of 1895, when he returned to Maryland. He was then employed by the United States Rubber Company in Baltimore and was later to transfer to the New York branch as company manager. He remained in New York until his retirement in the early 1920's. After this, he was chief accountant in the Maryland State Treasurer's Office, where he remained until about 1943 when he retired.

He was married in Sioux County, Nebraska by Rev. I. F. Lusk to Wisa Price, a teacher in that county.

He, his wife and young daughter are buried in Lorraine Cemetery, Baltimore (Lot #583-4).

John Spear Biggs was born in Jessup and spent his entire life on the same farm. He moved from the little house to the big house at the age of three or four. His early education was received in a one-room school which replaced the log building. It was on the north west corner of the original location of Race Road and the Old Annapolis Road (now 175) as shown on the Hopkins Map of 1878.

Jessup was one of the few rural communities in the country to have a school. The Anne Arundel County School System first came into existence in 1865 and was very slow in getting organized. (See "The First 100 Years" c. c. 1965, by Katherine

The latter part of John Spear(s) Biggs' education was received in a private school located on the Old Annapolis Road on the hill behind Dairyland Restaurant (Club 175) and was directed by Rev. Benjamin Griswold, an Episcopal clergyman.

As St. Mary's Episcopal Church in Jessup had a sporadic existence the Biggs family sometimes attended Trinity Church or a service held in the second floor of a Granger's Hall (the first floor was used as a school) in Annapolis Junction. It was here that John Spear Biggs met Grace Estelle Jones.

The community of Annapolis Junction wanted a church, so, along with an interested group, J. S. Biggs and Grace Jones set about working for funds to build one. This task was soon accomplished and in 1888 All Saints Church was erected on property donated by the Lloyd Dorsey family and dedicated on All Saints Day, November 1, 1888. It was in this church, on April 17, 1885, that John Spear Biggs and Grace Estelle Jones were married by the Rev. William F. Gardner, rector of Trinity Church.

Both John Spear Biggs and Grace Estelle Jones were confirmed in All Saints Church, their first three children baptized, and she remained as organist for ten years. At that time family duties prevented regular attendance.

About 1904, J. Spear Biggs and his family devoted full attention to St. Mary's Church, where both served in many capacities.. He was a vestryman, Sunday School superintendent, Bible Class teacher, etc., while his wife sang in the choir, was chairman of many benefit affairs, social affairs, etc.

J. Spear Biggs farmed with his father all of his early years. During the winter of 1896-1897 after the property was settled, he, with his wife, moved from the big house to the little house where he was born and where all four of his children were born and lived until they were grown. He remained active on his farm until shortly before his death.

He was buried from Trinity Church with the Rev. John J. Neighbour, formerly of St. Mary's Church, and the Rev. C. H. Fosbrooke, rector of Trinity Church, officiating, and interred in Meadowridge.

At his death all four children signed a waiver giving full ownership of the farm and house to his wife for her lifetime.

Grace (Jones) Biggs was born in Davidsonville, Anne Arundel County, Md. At an early age she with her family moved to Baltimore City where she attended the Methodist Church. She attended Girl's Grammar School on the southwest corner of Green and

Fayette Streets opposite *Westminster* Presbyterian Church (Edgar Allen Poe Church).

About 1880 her family moved to Annapolis Junction, where she lived for about ten years. At that time her family moved to Jessup and lived in a house on the same foundations where the Kenneth H. Fields, Sr.¹² home is at this time. The original house burned in 1899 or 1900.

Grace J. Biggs outlived her husband by twenty-three years during which she continued to live in the homestead. She was buried from Trinity Church by Rev. George Van Bibber Shriver, rector, and was interred in Meadowridge Cemetery. After her death the property (about thirteen acres) the rest having been sold earlier) was willed to the youngest and only remaining son, John Robinson Biggs.

Arthur Edward Biggs, Sr., was born and grew up in Jessup, Anne Arundel County, Maryland, where he attended the local school and St. Mary's Episcopal Sunday School and Church, where he was confirmed Nov 3, 1910, by Bishop Murray.

When the United States entered World War I he enlisted in the Fifth Maryland Regiment and was soon in uniform, training for duty. This regiment became part of the 29th Division. He was in Company A of the 115th Infantry, an all-Maryland Regiment He trained in Cockeysville, Md., Richmond, Va., and Camp McClellan, Alabama.

During the winter of 1917, he had pneumonia and in March, 1918, was given a physical discharge. His outfit was sent overseas very soon after his discharge.

After a few weeks at home he went to New York where, in 1919, he entered the employ of the United States Rubber Co., serving as stock clerk, floor salesman and city salesman. He worked diligently and merited a "write-up" in the company's year book for outstanding work.

In 1929 he was appointed sales manager of the Detroit Branch of the same company; in 1932 he was promoted to the same position in the St. Louis Branch; in 1934 he was moved to Buffalo where he was sales manager of the Buffalo, Rochester and Syracuse branches of the same firm.

By this time he had a wife and two little boys. He was still in this position when he contracted "strep-pneumonia" which took his life at the age of 37.

While living in New York City he became a member of the Masonic Lodge A. F. and A. M. and Pauline was a member of the Eastern Star.

He was buried from Trinity Church, Howard Co., and interred first in Chapel Hill Cemetery, then removed to Meadowridge Cemetery.

Arthur Edward Biggs, Jr. was born in New York City, and baptized at the age of three weeks in the Episcopal faith in or near West Englewood, N. J., confirmed in St. Phillip's Episcopal Church, Laurel, Maryland. When about a month old he went with his mother to join his father in Detroit, Michigan. In May, 1936 he, with his mother and little brother moved to Jessup (his father having died the year before). He attended the local school, Glen Burnie High School, and the University of Maryland, where, in 1951, he received his degree in Business Administration and his commission as 2d Lieutenant in the United States Air Force. He entered service soon afterward; volunteered for pilot training, was accepted and went to Molden AFB in Missouri; received advance training at Vance AFB in Enid, Oklahoma, where he graduated and received his wings. John William Biggs was born in Detroit, Michigan, baptized in Trinity Episcopal Church, Howard County, on July 21, 1933. His early life paralleled that of his brother, until 1954 when he entered active duty in the U.S.A.F.

Airsickness prevented him from becoming a pilot. However, he served from 1954 to 1957 as Budget and Accounting Officer, 3rd Bombardment Wing at Johnson Air Force Base, Japan, and advanced to 1st Lieutenant. He left an outstanding record and is now classified as a captain in the inactive reserves.

He attended Harvard Graduate School where he earned a master's degree in Business Administration.

Until 1968 he and his wife lived in Cincinnati, Ohio, where he was Director of Budgeting and Profit Planning for the Cincinnati Milling Machine Co. At present (1972) they are living in New Jersey.

G. Marie Biggs was born in Jessup, Anne Arundel County, Maryland, baptized in All Saints Episcopal Church, Annapolis Junction, A. A. Co., on August 10, 1902; attended St. Mary's Episcopal Sunday School and Church in Jessup, where she was confirmed on September 15, 1912, and where she remained an active member until the church was abandoned. At that time she became an active member of Trinity Episcopal Church, serving as Sunday School teacher for many years, as well as in many other capacities.

She attended the local school, Laurel High School, State Normal School and the University of Maryland.

She became an Elementary School teacher in the Anne Arundel School System and continued until her retirement in June 1959. She has served as teacher-principal in a one-room school, elementary teacher, teaching principal and as a supervising principal on the elementary school level. Thirty-five years of

this time was spent teaching in Jessup where she lived her entire life. She holds a life membership in the National Educational Society, The Maryland Congress of Parents and Teachers, The National Society Magma Charts Dames, and is an active member of the Woman's Club of Jessup. John R. Biggs, Sr, was born in Jessup, Anne Arundel County, Md., baptized in All Saints Church, Annapolis Junction, on August 10, 1902, attended Sunday School in St. Mary's Episcopal Church, Jessup, where he was confirmed Oct. 11, 1914 and was an active member until she. Mary's was closed. He then became active in Trinity Episcopal Church, Howard County. He has served several times as vestryman, treasurer for twelve years, secretary to the vestry and many other services.

During his life he farmed with his father. Later he worked at the Bartlett-Hayward Company, in 1930 was employed by the State of Maryland and worked at the Maryland House of Correction until his retirement in 1968.¹³

¹³ During this period, this annotator remembers Captain Biggs as a high ranking security officer (guards officer) at the Maryland House of Correction at Jessup (now closed), part of whose job was to refer escaped and other "charged" prisoners to the office of the Anne Arundel County prosecutor (State's Attorney) for prosecution for their offenses while they were prisoners there. During (or right after) World War II, there was a large scale "riot" at the House of Correction, and this annotator remembers well the day " they" (and this would have included Captain Biggs) brought, probably by bus, to the County Circuit Court House at Annapolis for trial and punishment, if convicted, those charged with riot and other offenses on that occasion. The historic main Court Room, including its historic gallery, were filled with the prisoners and their armed guards; it was quite a sight.

In 1964 he became a member of Solomon Lodge No. 171, A. F. & A. M. of Savage, Md., a lodge of which, in 1865, his great grandfather, John Spears, was one of the nine founding fathers. In 1965, he was elected treasurer of the lodge, an office he still holds.

Cora, his wife, moved to Baltimore while young. She worked as a bookkeeper for the United States Fidelity and Guarantee Insurance Company, Inc., until August 1933. At this time she resigned and applied her attention to homemaking and rearing her family. John Robinson Biggs, Jr., attended Anne Arundel County Schools, graduated from Glen Burnie High School. He attended Trinity Episcopal Sunday School, was baptized June 23, 1934 and

confirmed September 21, 1947; was a member of the Teen Club, and sang in the choir until he enlisted in the U.S.A.F. on March 29, 1953.

He was first in the 640th AC&W Squadron (Air Craft Warning) in Ernest Harmon AFB, Stephenville, Newfoundland, then in the 965th AEW&C Squadron (Airborne Early Warning and Control) in McClellan AFB, California, where he helped patrol the Pacific Coast. He was discharged from active service March 19, 1957.

William Spear Biggs attended the neighborhood school, Arundel Jr. Sr. High School, where he was a member of the National Honor Society. He attended University of Maryland and the University of Baltimore.

As a high school junior his summer work was writing news reports of activities of the ROTC in Fort Meade, which lasted only during the summer. Being interested in journalism he pursued this line. His first full time work was writing for the Second Army News - "The Sentinel", later renamed "The First US Army Voice." In 1967 he transferred to the Social Security Building; at Woodlawn, Baltimore, as a writer-editor of the "Oasis", and other news letters.

He attended Trinity Church, Sunday School, was baptized, confirmed in May 1950, sang in the choir, was organist, and later was choir director.

He was a good pianist and for two years student voice training at Peabody Preparatory School of Music, Baltimore.
